Motion: *by Select Board Member St.Cyr to wait till the next meeting to approve the minutes as not all members had read them.*

Second: *by Select Board Member Whittum*

Vote: 2-0-0

Select Board Member Whittum - Everyone did a good job at town meeting and is confident everyone can work together.

Select Board Member St.Cyr - Thanked former Selectman Crosby (on speaker phone) for all the work he did for the town of Dalton.
